CCA Girls BB Go to State

By the time this column has been submitted for press, the fate of the Clear Creek Amana Girls basketball team will be sealed as they play the first round of the Class 4A tournament on Tuesday, Feb. 28 at 3:15.

They are facing Number 2 North Pork with a 21-2 record. The Number 7 CCA team is 18 and 4.

This is only the second time in the history of the CCA school district that the CCA girls have advanced to the state basketball tournament. The first time was in 2020. They are coached by PJ Sweeney.

A note for those who enjoy Iowa history and girls' basketball. A podcast on the unique story of Iowa's 6 on 6 girls basketball was created by Elly Gordon-Moerschel, Toronto, for the national podcast "99 percent invisible," hosted by Roman Mars. The show includes interviews with some of the biggest names in 6 on 6 Iowa BB and perspectives from Hawkeye Coach Lisa Bluder and others with a bead on women's sports in Iowa, plus a couple of Gordon-Moerschel's family members who played the game. Yes, there's stories about Amana girls basketball in it too. Elly Gordon-Moerschel is the granddaughter of the late Marietta Moerschel and the daughter of Rebecca Moerschel, graduate of Amana High School Class of 1967. Public Meeting Addresses Concerns as Questions are Raised

Amana Elementary parents and residents had the opportunity to ask questions and share concerns with Dr. Corey Seymour, Clear Creek Amana School Superintendent, and school board member, Jen Mooney, at last week's public meeting about the changes proposed for the 2023-24 school year and the plans to make the Amana Elementary a magnet school.

About 50 people attended the meeting. A second town hall is planned for March 27 at 6 p.m. at the Amana Performing Arts Center, Amana.

Those who attended heard more about the decision to send the Amana 5th grade, as well as all other 5th grades in Oxford and Tiffin, to the Oak Hill building in Tiffin, next fall. They also heard plans for the Amana magnet school. Creating a magnet school means creating curriculum beginning in kindergarten that will feature fine arts, a foreign language and financial literacy. This will require a multi-year roll-out Dr. Seymour and

Principal Ben Macumber told parents.

As Amana Elementary Principal Ben Macumber told us after the meeting, "It was exciting to have such a large group of people passionate about students, the Amana building and the community of Amana in general. I am excited about the opportunities planned for Amana Elementary as well as students from CCA and surrounding communities. To be able to rethink what school can be like. To be part of something that could have a lasting impact on education long after I retire inspires me." He encouraged anyone who has questions to contact him.



Roger Duane Gaddis, 86, passed away on Thursday, February 16, 2023, in Plano, TX.

Roger, son of Merle Gaddis and Helen (Schaefer) Gaddis Heinze, was born on June 26, 1936 in East Amana, Iowa. Roger attended school in Amana graduating in 1954. He lettered in basketball and baseball. He served briefly in the Iowa National Guard.

After high school, he served honorably in the U.S. Army, stationed in Germany for most of his service, from January 1955 until January 1957. During this time he was united in marriage to his high school sweetheart Pauline Fink.

He graduated from the U. of Iowa in 1960. In 1962 he began a career with the U.S. Department of the Treasury in the Kansas City area, eventually being transferred to the Washington, D.C. area in 1969. He retired from the Treasury after 33 years in 1995. He then worked at the Illinois Institute of Technology in D.C. from 1996-2002. He and his wife Pauline moved to Plano, TX in 2002 to retire near family.

Roger loved classical and choral music, belonging to church choirs in Overland Park KS, Bowie, MD, the Chesapeake Choral Society, and finally, the Plano Choral Society.

He had a lifetime love of learning and enjoyed opera, orchestral music, bluegrass, folk music, ballroom and polka dancing, and musical theatre. He loved sharing stories and spending time with his children and grandchildren.

Roger is survived by his sister Patricia Hergert (Richard) of DeWitt, IA; son Merle Gaddis (Kelly) of Olathe, KS; son Robert Gaddis (Vivian Garcia) of Redondo Beach, CA; daughter Melissa Toohey (Peter) of Plano, TX. He is also survived by his 5 grandchildren—Melissa Gaddis (Owen Phillips) of Salt Lake City, UT; Kristin Gaddis of Overland Park, KS; Brendan Toohey (Jessica) of Dallas, TX; Sofia Toohey of New York City, NY; and Schaefer Toohey of Plano, TX; his sister-in-law Gerda Holub; his brother-in-law Fred Finch (Laura); and 9 nieces and nephews.

He was preceded in death by his father Merle Gaddis, mother Helen Gaddis Heinze, stepfather Adolph Heinze, and wife Pauline Gaddis. He will be greatly missed by all his family and friends.
