AMANA NEWS AND NOTES

New Clubhouse Under Construction at the Amana Colonies Golf Club

Construction is well underway for the new clubhouse with 8,000 square feet on the main floor and 4,000 square feet on the lower level.

Excitement builds as the new clubhouse nears completion. Of course, the current clubhouse and all 18 holes opened for spring a couple of weeks ago. The new clubhouse is now fully enclosed and the siding is going on. Interior finishing is underway. Kahler hopes the new facility will be open later in June.

The new Amana clubhouse built by Septagon Construction for the Amana Society, Inc. will offer more space for the golf shop, a larger sandwich shop with indoor and outdoor seating, a banquet room, a larger kitchen, restrooms, permanent space for the golf simulators for year-round play and office space.

Stephen Kahler, PGA general manager Amana Colonies Golf Club, shared details, "We're excited to have a new clubhouse that will be more in-line with the quality of the golf course. Our goal has always been to restore Amana Colonies Golf Club as one of the top courses in the state. The new clubhouse will check another box off our long-term capital improvement list."

"When Kahler Golf built the current clubhouse in 2016, we designed it to give us the flexibility to build a bigger one someday if our business levels justified it. . . We are proud to say that since 2016, we have seen our rounds and revenue increase each and every year. So much so, that we have now outgrown our space. Yes, the current clubhouse and Lakeside Barn have served their purpose, but are no longer sufficient for our growing business levels."

Readers may recall that the first clubhouse at the course burnt down in November of 2015. In 2016 Kahler took on the course and built the replacement clubhouse and then rebuilt Lakeside Barn.

In 2020 Amana Society purchased the business and together Kahler Golf and ASI have made significant improvements, building the new maintenance building, installing a new pump station and irrigation system, improved cart paths, enhanced course conditions, new maintenance equipment and new, leased golf carts. They plan more bunker renovations too.

"The course has been very successful under the management of Kahler Golf," said Bruce Trumpold, Amana Society, Inc. secretary-treasurer.

"We are committed to providing the best experience we possibly can for our guests," Kahler said, adding that he and his staff are very proud of the course and the quality of the experience they offer.

"We have always been firm believers that the main draw to Amana Colonies Golf Club is the golf course itself and the beauty of the land. Therefore our focus over the last 8 years has been on providing the best playing conditions possible, making the course more enjoyable for all skillsets, addressing some significant deferred maintenance, and creating a comfortable atmosphere where our guests feel welcome and appreciated.

Part of the fun of a clubhouse is relaxing with friends in an enjoyable setting for lunch or a snack after a round of golf. The sandwich shop at the new clubhouse will remain just that, a place

golfers can unwind, offering cheeseburgers, deli sandwiches, Amana Bratwurst, hot dogs, and other menu items appealing to golfers. And with a new banquet room in the clubhouse there's the option for events at the clubhouse just steps from parking.

VETERANS’ ECKE

“Iowa Disabled Veteran Tax Credit”

One of the many benefits that Iowa Offers our veterans is the tax credit that provides 100% exemption of property taxes for 100% disabled service-connected veterans and Dependency and Indemnity Compensation (DIC) recipients.

Is annual reapplication required?

No, annual reapplication is no longer required. Instead, a notification to the assessor is required if a veteran or surviving spouse no longer qualifies for the credit. The income restriction is no longer required to receive the credit.

Application Process

What is the filing deadline?

The filing deadline for the application is July 1. Applications received after July 1 would apply to the following assessment year.

Is a veteran’s application and supporting documentation a public record?

Applications for Disabled Veteran Tax Credits are public record. The applicant will need to be aware to limit the provision of private health related information and redact any social security numbers or information from the supporting documentation. However, under Iowa Code section 425.15(5), the list of the names and addresses of individuals granted a credit is generally considered confidential information.

Under Iowa Code section 425.2(3), if the owner of the homestead is in active service in the armed forces of this state or the United States, or is sixty-five years of age or older, or is disabled, the application may be signed and delivered by any member of the owner’s family, by the owner’s guardian or conservator, or by any other person who may represent the owner under power of attorney. If the owner of the homestead is married, the spouse may sign and deliver the application.

3. Applicants Receiving Other Tax Credits If the assessor receives a new application, and the applicant has previously applied for a homestead credit or military exemption, should the assessor remove that credit or exemption?

A qualifying person who elects to secure the credit provided in this section is not eligible for any other real property tax exemption provided by law for veterans of military service. Iowa Code § 425.15(3). If the applicant does not qualify for the disabled veteran additional homestead credit and had been receiving a homestead credit previously, the applicant would be entitled to receive their original homestead credit without reapplication.
